**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via  
SMALL VALUE PROCUREMENT TO VERJANDEL HOTEL INC. FOR THE  
PROCUREMENT OF ROOM ACCOMMODATIONS AND MEALS FOR THE  
ATTENDEES OF CESB TRAINING ON 16-18 JULY 2024**

**WHEREAS**, the Philippine Information Agency – Human Resource Development Division (HRDD) submitted its Purchase Request for the **PROCUREMENT OF ROOM ACCOMMODATIONS AND MEALS FOR THE ATTENDEES OF CESB TRAINING ON 16-18 JULY 2024** with an Approved Budget for the Contract (ABC) of **ONE HUNDRED FORTY-EIGHT THOUSAND FOUR HUNDRED PESOS ONLY (PHP 148,400.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

**WHEREAS**, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

**WHEREAS**, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPs website and sent the same to the various prospective suppliers on **06 July 2024**;

**WHEREAS**, after the closing date on **9 July 2024**, various suppliers submitted their quotations appearing herein as ANNEX A and the Abstract of Quotation as Annex B;

**WHEREAS**, hereunder is the summary of the price quotations received:

**WHEREAS, THE ORACLE HOTEL & RESIDENCES** was subjected to a Post Qualification Assessment by the designated member of the Technical Working Group (TWG) on **09 July 2024**;

**WHEREAS**, during the conduct of the Post Qualification Evaluation, the TWG Representative End-User Representative and Procurement Staff witnessed an alleged food poisoning incident at the Lobby of the Hotel;

**WHEREAS**, based on the report submitted by the TWG Representative, the PIA-COBAC unanimously agreed not to risk the safety of the PIA Officials who will be staying in the hotel and thereafter rendered The Oracle Hotel & Residences as not responsive;

**WHEREAS**, NPM No. 024-2018 instructs that the verification under the post-qualification stage is not limited to the examination of documents submitted by the bidder, but also includes inspection of the subject matter.

**WHEREAS**, the second lowest calculated bid, **VERJANDEL HOTEL INC.** was subjected to a Post Qualification Evaluation;

**WHEREAS**, the proposal of **VERJANDEL HOTEL INC.** conforms to the requirements of PIA and the law, and its price quotation of **One Hundred Three Thousand Two Hundred Pesos Only (PHP 103,200.00)** inclusive of tax, is within the ABC, and the most economical and advantageous to the government, thereby rendering the same as the Most Responsive Quotation;

**WHEREAS**, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

**NOW, THEREFORE**, in consideration of the foregoing, WE, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMENDS** the award via Small Value Procurement to **VERJANDEL HOTEL INC.** for the **Procurement of Room Accommodations and Meals for the Attendees of CESB Training on 16-18 July 2024** in the amount of **One Hundred Three Thousand Two Hundred Pesos Only (PHP 103,200.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
