**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
SMALL VALUE PROCUREMENT TO ULY TECH TRADING FOR LOTS 1
AND 2 FOR THE SUPPLY AND DELIVERY OF VARIOUS AUDIO AND
VIDEO PRODUCTION EQUIPMENT AND REPOSTING OF LOTS 3 AND 4**

WHEREAS, the Philippine Information Agency – Creative and Production Services Division (CPSD) submitted a Purchase Request for the **SUPPLY AND DELIVERY OF VARIOUS AUDIO AND VIDEO PRODUCTION EQUIPMENT (LOTS 1 to 4)** with an Approved Budget for the Contract (ABC) of **THREE HUNDRED EIGHTY-THREE THOUSAND PESOS ONLY (PHP 383,000.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency with the details as follows;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 14 June 2024;

WHEREAS, the posting of Purchase Request was divided into four (4) Lots with details as follows:

WHEREAS, the following are the results of the evaluation and deliberation of quotations received;

Description	Recommendation
Lot 1: Laser Presentation and Remote	Only ULY TECH TRADING submitted a quotation for Lot 1 and the lowest quotation for Lot 2, and thus subjected to a Post Qualification Assessment by the designated Technical Working Group (TWG).
Lot 2: Audio Mixers and Speakers	
Lot 3: Led Lights	Pursuant to the BAC meeting held on June 26, 2024, the committee recommended reposting the RFQ due to the non-receipt of quotations.
Lot 4: 4-Ch HDMI Video Switcher	Pursuant to the BAC meeting held on June 26, 2024, the committee recommended reposting the RFQ due to the non-receipt of quotations.

WHEREAS, ULY TECH TRADING was subjected to Post Qualification Assessment by the designated Technical Working Group (TWG) representative on 3 July 2024;

WHEREAS, after evaluation of the submitted quotation and other eligibility documents, quotations were found to conform to the requirements of the PIA and the law, inclusive of tax, within the ABC, and the most economical and advantageous to the government, thereby rendering it as the Lowest Calculated and Most Responsive quotations for the following;
