**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via  
PUBLIC BIDDING FOR GOODS TO JONECO TECH MARKETING CORP.  
FOR THE PROCUREMENT OF ONE (1) LOT EQUIPMENT FOR THE  
WORKPLACE MODERNIZATION PROJECT (ITB 2024-05)**

**WHEREAS**, the Philippine Information Agency – Management Information System Division (MISD) submitted its Purchase Request for the **PROCUREMENT OF ONE (1) LOT EQUIPMENT FOR THE WORKPLACE MODERNIZATION PROJECT (ITB 2024-05)** with an Approved Budget for the Contract (ABC) of **FIVE MILLION SEVEN HUNDRED EIGHTY-FIVE THOUSAND PESOS ONLY (PHP 5,785,000.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

**WHEREAS**, the *Bids and Awards Committee (BAC)*, as mandated by Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act” is the body tasked to post invitation to bid, conduct pre-bid conferences, determine the eligibility of prospective bidders, receive and open bids, conduct the evaluation of bids, conduct post qualification and recommend award of contract to the Head of the Procuring Entity (HoPE);

**WHEREAS**, pursuant to the prescribed process of Competitive Bidding, the BAC together with its Secretariat, member of the Technical Working Group (TWG) and End-User representative conducted a Pre-Procurement Conference on 04 June 2024 at 2:00 P.M.;

**WHEREAS**, on 10 June 2024, Invitation to Bid (ITB 2024-05): Public Bidding for Goods for the **Procurement of One (1) Lot Equipment for the Workplace Modernization Project** was published on the Philippine Government Electronic Procurement System (PhilGEPS), PIA website ([www.pia.gov.ph](http://www.pia.gov.ph)), PIA official social media account and in the BAC Bulletin Board within the premises of PIA;

**WHEREAS**, for purposes of transparency and good governance, the BAC, through its Secretariat, invited observers from the Commission on Audit (COA) and two (2) other non-government organizations namely Philippine Chamber of Commerce and Industry (PCCI), and Philippine Rural Reconstruction Movement (PRRM) to witness the Pre-Bid Conference and Bid Opening. However, only the representative from COA attended the Pre-Bid Conference and no observers attended the Bid Opening. Copies of the letters of invitation are hereto attached;

**WHEREAS**, on 18 June 2024 at 1:30 P.M., the BAC held a Pre-Bid Conference via hybrid set-up, to discuss the eligibility requirements and the



technical and financial components of the contract for bidding Nine (9) prospective bidders attended the said activity through videoconferencing via Google Meet Link ([meet.google.com/yww-fwss-wrw](https://meet.google.com/yww-fwss-wrw));

**WHEREAS**, in response to the Invitation to Bid, two (2) bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 01 July 2024 at 12:00 P.M., to wit: [copies of the Official Receipts (ORs) are hereto attached]

**WHEREAS**, the scheduled Bid Opening on 01 July 2024 at 1:30 P.M. was postponed due to the Official Travel of the BAC Chairperson, Vice Chairperson, and Head BAC Secretariat, to 05 July 2024 at 10:00 A.M.; [copy of Notice of Postponement hereto attached]

**WHEREAS**, during the Opening of Bids on 05 July 2024 at 10:00 A.M., upon the determination of a quorum, the BAC conducted the opening of bids and preliminary examination and the following were the results:

**WHEREAS**, the opening of the financial proposal of the two (2) bidders followed after they passed the preliminary evaluation and were declared eligible;

**WHEREAS**, after the assessment of the BAC of the bidder's Bid Price and the Bid Form, the result was read as follows:

**WHEREAS**, the BAC declared the bid of Joneco Tech Marketing Corp. as the Lowest Calculated Bid (LCB), and was subjected to Post-Qualification Evaluation on 19 July 2024, pursuant to Section 34.2 of the Revised Implementing Rules and Regulations (RIRR) of R.A No. 9184, to determine whether it complies with and is responsive to all requirements and conditions specified in the Bidding Documents;

**WHEREAS**, on 19 July 2024, pursuant to the instruction of the BAC, the designated member of the TWG conducted the necessary Post-Qualification Evaluation activity to verify and validate the submitted documents of Joneco Tech Marketing Corp, which were found compliant with

and responsive to all the requirements and conditions specified in the Bidding Documents;

**WHEREAS**, after careful examination, validation, and verification of all eligibility, technical and financial requirements, the bid of Joneco Tech Marketing Corp. was found to conform to the requirements of PIA and the law, and its bid proposal of **FOUR MILLION EIGHT HUNDRED EIGHTY-TWO THOUSAND TWO HUNDRED EIGHTY-FIVE PESOS ONLY (PHP 4,882,285.00)**, inclusive of tax, is within the ABC and advantageous to the government, thereby rendering the same having the *Lowest Calculated and Responsive Bid (LCRB)*;

**NOW, THEREFORE**, in consideration of the foregoing, WE, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMEND** the award via Public Bidding of Goods to **JONECO TECH MARKETING CORP.** for the **PROCUREMENT OF ONE (1) LOT EQUIPMENT FOR THE WORKPLACE MODERNIZATION PROJECT** in the amount of **FOUR MILLION EIGHT HUNDRED EIGHTY-TWO THOUSAND TWO HUNDRED EIGHTY-FIVE PESOS ONLY (PHP 4,882,285.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
