RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via SMALL VALUE PROCUREMENT TO EGMJ TRADING FOR THE SUPPLY AND DELIVERY OF VARIOUS MOTOR VEHICLE PARTS AND SUPPLIES (LOTS 1 to 3)

WHEREAS, the Philippine Information Agency – Administrative Division (Admin) submitted a Purchase Request for the SUPPLY AND DELIVERY OF VARIOUS MOTOR VEHICLE PARTS AND SUPPLIES (LOTS 1 to 3) with an Approved Budget for the Contract (ABC) of SIX HUNDRED THREE THOUSAND SIX HUNDRED SEVENTY-SEVEN PESOS ONLY (PHP 603,677.00) inclusive of tax and included in the Annual Procurement Plan of the Agency with the details as follows;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 18 July 2024;
