**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
SMALL VALUE PROCUREMENT TO NUNTIUS ELECTRONICS INC. FOR THE
SUPPLY AND DELIVERY OF NINE (9) UNITS OF LAPTOP COMPUTER**

WHEREAS, the Philippine Information Agency – Knowledge Management and Strategic Communication (KMSC) submitted a Purchase Request for the **SUPPLY AND DELIVERY OF NINE (9) UNITS OF LAPTOP COMPUTER** with an Approved Budget for the Contract (ABC) of **FOUR HUNDRED NINE THOUSAND SEVEN HUNDRED TWENTY-SIX AND 53/100 PESOS ONLY (PHP 409,726.53)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 29 August 2024;

WHEREAS, after the closing date on 2 September 2024, eleven (11) prospective suppliers submitted their quotation namely 1. OUR GREAT HOME STYLE DEPOT CORP., 2. PERRY A TRADING, 3. ABLAZE MARKETING, 4. VIMISO COMPUTER STORE, 5. MMBT TELECOMMUNICATION EQUIPMENT TRADING, 6. LUXERBERG MARKETING, INC., 7. BAYANPC TECHNOLOGIES, INC., 8. NUNTIUS ELECTRONICS INC., 9. DCI INT'L. I.T. SOLUTIONS AND SERVICES CORPORATION, 10. SONKKENS OFFICE EQUIPMENT TRADING, and 11. GABEPAT TRADING herein as ANNEX A and the Abstract of Quotation as Annex B;

WHEREAS, the following are the results of the evaluation and deliberation of quotations received;

OUR GREAT HOME STYLE DEPOT CORP.,	Submitted the lowest quotation, however, failed to comply with the Technical Specifications.
MMBT TELECOMMUNICATION EQUIPMENT TRADING	Submitted the 2 nd lowest quotation, however, failed to comply with the Technical Specifications.
ABLAZE MARKETING	Submitted the 3 rd lowest quotation, however, failed to comply with the Technical Specifications.
NUNTIUS ELECTRONICS INC.	Submitted the 4 th lowest quotation and was subjected to Post Qualification Assessment by the designated Technical Working Group (TWG) representative on September 20, 2024.

WHEREAS, NUNTIUS ELECTRONICS INC. was subjected to Post Qualification Assessment by the designated Technical Working Group (TWG) representative on 20 September 2024;

WHEREAS, after careful evaluation of the submitted quotation and other eligibility documents, the proposal of NUNTIUS ELECTRONICS INC. conforms to the requirements of PIA and the law and its price quotation of THREE HUNDRED SIXTY THOUSAND PESOS ONLY (PHP 360,000.00) inclusive of tax, is within the ABC, and the most economical and advantageous to the government, thereby rendering the same as the Lowest Calculated and Responsive Quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, in consideration of the foregoing, WE, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMENDS** the award via Small Value Procurement to NUNTIUS ELECTRONICS INC. for the **SUPPLY AND DELIVERY OF NINE (9) UNITS OF LAPTOP COMPUTER** in the amount of **THREE HUNDRED SIXTY THOUSAND PESOS ONLY (PHP 360,000.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
