**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT
via PUBLIC BIDDING TO CGS SOLID AIRCON AND REFRIGERATION, INC
FOR SUPPLY, DELIVERY AND INSTALLATION OF FIFTEEN (15)
AIR CONDITIONING UNITS ITB 2024-06-A**

WHEREAS, the Philippine Information Agency – Administrative Division (Admin), submitted the Purchase Request for the **SUPPLY, DELIVERY, AND INSTALLATION OF FIFTEEN (15) AIR CONDITIONING UNITS ITB 2024-06-A** with an Approved Budget for the Contract (ABC) of **TWO MILLION SEVEN HUNDRED THIRTY-SEVEN THOUSAND THREE HUNDRED FIVE PESOS ONLY (Php 2,737,305.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, pursuant to the rules of Competitive Bidding, the BAC together with its Secretariat, Members of the Technical Working Group (TWG) and End-User Representative conducted a Pre-Procurement Conference on 14 August 2024 at 9:30 AM, Procurement Conference;

WHEREAS, on **19 August 2024** the Philippine Bidding Documents for **Public Bidding for Goods for the Supply, Delivery and Installation of Fifteen (15) Air Conditioning Units ITB 2024-06-A** was published on the Philippine Government Electronic Procurement System (PhilGEPS), in the PIA website (www.pia.gov.ph), PIA official social media account and in the Bids and Awards Committee Bulletin Board within the premises of PIA consistent with Section 21, Rule VII of the 2016 revised IRR of RA 9184;

WHEREAS, for purposes of transparency and good governance, the BAC through its Secretariat invited observers from the Commission on Audit (COA) and two (2) other non-government organizations namely Philippine Rural Reconstruction Movement (PRRM) and Philippine Chamber of Commerce and Industry (PCCI) to witness the Pre-Bid Conference and Bid Opening. However, no representative attended the said activities. Copies of the letter of invitations are hereto attached;

WHEREAS, from 19 August 2024 to 09 September 2024, the bidding documents were made available for procurement for interested prospective bidders;

WHEREAS, the BAC conducted a scheduled Pre-Bid Conference on 27 August 2024 at 10:00 AM, twelve (12) prospective bidders participated the activity via Onsite namely 1) Freeman Enterprises 2) 3HD Air Conditioning Systems Services 3)CGS Solid Aircon and Refrigeration, Inc. 4) Sun Valley Multi-Purpose Cooperative 5) R Bros Enterprises and via Google Meet 6) Amigotek Corporation 7)Berns Engineering

Sales and Services 8) Deokma Trading 9) Clearshot Builders 10) Climatech Mega Solutions 11) Buoyant Industrial Systems Inc. 12) Innovalite Trading;

WHEREAS, as a result of discussion and clarifications the BAC issued and published **Supplemental Bid Bulletin No.1** on 29 August 2024;

WHEREAS, eight (8) bidders purchased and submitted their bids prior the deadline of submission on 09 September 2024, 12:00 PM below is the summary of submission;

WHEREAS, during the opening of bids on 09 September 2024 at 1:30 P.M. attended by the BAC in quorum, it's Secretariat, End-User Representative, designated Technical Working Group (TWG) Representative and bidder's representative. The bid proposals were evaluated using the non-discretionary "PASS/FAIL" criterion;

WHEREAS, Innovalite Inc. Philgeps Registration Certificate (Platinum Membership) under "CLASS A " Documents, "Annex A" : PCAB License expired on September 8, 2024. Purcuant to the Bidding Document under Checklist of Technical and Financial (all pages) **in accordance with Section 8.5.2 of the IRR;**

Section 8.5.2

All bidders shall upload and maintain in PhilGEPS a current and updated file of the following Class "A" eligibility documents under Sections 23.1(a) and 24.1(a)

- (a) Registration Certificate;
- (b) Mayor's/Business Permit or its Equivalent Document;
- (c) Tax Clearance;
- (d) Philippine Contractors Accreditation Board (PCAB) license and registration; and
- (e) Audited Financial Statements

For the purpose of updating the Certificate of Registration and Membership, all Class "A" eligibility documents mentioned in this

section supporting the veracity, authenticity and validity of the Certificate shall remain current and updated. The failure by the prospective bidder to update its Certificate with the current and updated Class "A" eligibility documents **shall result in the automatic suspension of the validity of its Certificate until such time that all of the expired Class "A" eligibility documents has been updated.**

WHEREAS, due to suspended validity of its Philgeps Platinum Certificate and thus failure to comply the "TECHNICAL COMPONENT". The committee unanimously resolves to "DISQUALIFY" Innovalite Inc;

WHEREAS, after the evaluation of bid proposals, below is the summary of evaluation;

WHEREAS, the bid proposal of CGS Solid Aircon & Refrigeration Inc was declared as the LOWEST CALCULATED BID;

WHEREAS, on 12 September 2024, pursuant to the instruction of the BAC, the designated TWG Representative conducted the necessary Post Qualification proceedings to CGS Solid Aircon & Refrigeration Inc with registered business Lazatin Blvd. Villa Victoria RD., Dolores, San Fernando City Pampanga;

WHEREAS, after careful examination, validation and verification of all the documents submitted, the bid of CGS SOLID AIRCON & REFRIGERATION INC conforms to the requirements of PIA and the law, and its bid proposal of **ONE MILLION EIGHT HUNDRED THIRTY-FIVE THOUSAND SEVEN HUNDRED NINETY-NINE PESOS ONLY (PHP 1,835,799.00)** inclusive of tax is within the ABC

, most economical and advantageous to the government, thereby rendering the same as the *Lowest Calculated and Responsive Bid (LCRB)*;

WHEREAS, pursuant to Section 36 of the Revised Implementing Rules and Regulations of RA 9184 states that;

12.1 The LCB shall be subject to post-qualification in accordance with Section 34, Rule X of this IRR to determine its responsiveness to the eligibility and bid requirements. If after post-qualification the Lowest Calculated Bid is determined to be post-qualified it shall be considered *the Lowest Calculated and Responsive Bid (LCRB)* and the contract shall be awarded to the bidder. In case of post-disqualification of the LCB, the procedure under Section 34 shall also be followed.

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, for all and in consideration of the foregoing, WE, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMENDS** to award via PUBLIC BIDDING OF GOODS to **CGS SOLID AIRCON & REFRIGERATION INC** for the **SUPPLY, DELIVERY AND INSTALLATION OF FIFTEEN (15) AIR CONDITIONING UNITS ITB 202406-A** in the amount of **ONE MILLION EIGHT HUNDRED THIRTY-FIVE THOUSAND SEVEN HUNDRED NINETY-NINE PESOS ONLY (PHP 1,835,799.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
