RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via SMALL VALUE PROCUREMENT TO METOS OFFSHORE, INC. FOR THE PROCUREMENT OF ONE (1) YEAR SUBSCRIPTION OF MULTIMEDIA SOFTWARE LICENSES - CREATIVE CLOUD ALL APPS

WHEREAS, the Philippine Information Agency – Creative and Production Services Division (CPSD) submitted its Purchase Request for the Procurement of One (1) Year Subscription of Multimedia Software Licenses – Creative Cloud All Apps with an Approved Budget for the Contract (ABC) of ONE HUNDRED TWENTY THOUSAND PESOS ONLY (Php 120,000.00), inclusive of tax and included in the Annual Procurement Plan of the Agency;

**WHEREAS**, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H – Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website, the official website of the PIA as Procuring Entity, PIA social media platforms and sent the same to various prospective suppliers on 26 September 2024;

**WHEREAS,** after the closing date on 1 October 2024, the following suppliers submitted their quotations namely 1) Metos Offshore, Inc.; 2) AGMS Information Technology Inc.; and 3) BayanPC Technologies, Inc. appearing herein as ANNEX A and the Abstract of Quotation (AoQ) as ANNEX B;

**WHEREAS**, hereunder is the summary of the quotations received:

**WHEREAS,** the lowest quotation submitted by **METOS OFFSHORE, INC.** was subjected to *virtual/online post-qualification assessment* by the designated member of the Technical Working Group (TWG) on 14 October 2024;

**WHEREAS,** after review and evaluation, the TWG found that **METOS OFFSHORE, INC.** is legally, financially, and technically capable to undertake the subject procurement and for having submitted the lowest and most responsive quotation;

WHEREAS, the proposal of METOS OFFSHORE, INC. for the Procurement of One (1) Year Subscription of Multimedia Software Licenses - Creative Cloud All Apps conforms to the requirements of PIA and the law and its price quotation of Eighty-Nine Thousand Five Hundred Fifty-Four Pesos Only (Php 89,554.00), inclusive of tax, is within the ABC, and the most advantageous to the government, thereby rendering the same as the lowest and most responsive quotation;

**WHEREAS,** Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, in consideration of the foregoing, WE, the Members of the PIA BIDS AND AWARDS COMMITTEE, by virtue of the powers vested on us by law, hereby RECOMMEND the award via Small Value Procurement to METOS OFFSHORE, INC. for the PROCUREMENT OF ONE (1) YEAR SUBSCRIPTION OF MULTIMEDIA SOFTWARE LICENSES - CREATIVE CLOUD ALL APPS in the amount of EIGHTY-NINE THOUSAND FIVE HUNDRED FIFTY-FOUR PESOS (Php 89,554.00) inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
