**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
SMALL VALUE PROCUREMENT TO MKS FURNITURE FOR THE SUPPLY
AND DELIVERY OF ONE (1) LOT OF FURNITURES AND FIXTURES FOR
PHILIPPINE INFORMATION AGENCY**

WHEREAS, the Philippine Information Agency – Office of the Director General (ODG) submitted a Purchase Request for the **SUPPLY AND DELIVERY OF ONE (1) LOT OF FURNITURES AND FIXTURES FOR PHILIPPINE INFORMATION AGENCY** with an Approved Budget for the Contract (ABC) of **THREE HUNDRED TWENTY-SEVEN THOUSAND FOUR HUNDRED NINETY-SEVEN 60/100 ONLY (PHP 327,497.60)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 07 October 2024;

WHEREAS, after the closing date on 10 October 2024, **twelve (12) prospective suppliers submitted their quotations** namely 1.Design Crest Furniture Component, 2. New A.G Stylist Furniture, 3 MKS Furniture, 4.RCQ Disaster Supplies and Trading, 5. Christine-Arcy Furniture Designs, Inc. 6. GAMMA Line Enterprises, 7. 3RMD Furniture Trading, 8. JC Prime Non-Specialized Wholesales Trading, 9. Playmaker Sports Inc., 10. 999 Clique Enterprises, 11. Suntawood Home and Office Inc., 12. Design

Excellence Home & Office System Co appearing herein as ANNEX A and the Abstract of Quotation as Annex B;

WHEREAS, supplier **MKS Furniture** was subjected to post qualification assessment by the designated member of the Technical Working Group (TWG) on 31 October 2024;

WHEREAS, after review and evaluation, the TWG found that **MKS Furniture** is legally, financially, and technically capable to undertake the subject procurement, and for having submitted a responsive quotation;

WHEREAS, as provided for in the GPPB Manual of Procedures for the Procurement of Goods and Services, Volume 2, the concept of value for money is not restricted to price and includes non-cost factors like suitability of fitness to the purpose, quality, etc. among others including completeness and compliance to the requirements;

WHEREAS, the proposal of **MKS Furniture** for the **Supply and delivery of One (1) lot of Furnitures and Fixtures for Philippine Information Agency** conforms to the requirements of PIA and the law and its price quotation of **TWO HUNDRED TEN THOUSAND ONE HUNDRED FIFTY PESOS ONLY (PHP 210,150.00)**, inclusive of tax, is within the ABC, and thereby rendering the same as a responsive quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, in consideration of the foregoing, **WE**, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMEND** the award via *Small Value Procurement* to **MKS FURNITURE** for the **SUPPLY AND DELIVERY OF ONE (1) LOT OF FURNITURES AND FIXTURES FOR PHILIPPINE INFORMATION AGENCY** in the amount of **TWO HUNDRED TEN THOUSAND ONE HUNDRED FIFTY PESOS ONLY (PHP 210,150.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
