**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
SMALL VALUE PROCUREMENT TO ALPHA DIGIZONE MARKETING FOR
THE SUPPLY AND DELIVERY OF LOT 1 – 2 UNITS VIDEO SWITCHER**

WHEREAS, the Philippine Information Agency – Creative and Production Services Division (CPSD) submitted its Purchase Request for the **Supply and Delivery of Two (2) Lots of Audio Visual Equipment** with an Approved Budget for the Contract (ABC) of **ONE HUNDRED FIVE THOUSAND PESOS ONLY (Php 105,000.00)**, inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H – Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website, the official website of the PIA as Procuring Entity, PIA social media platforms and sent the same to various prospective suppliers on 24 September 2024;

WHEREAS, the Purchase Request and posting was divided into two (2) lots with details as follows:

LOTS	DESCRIPTION	ABC AMOUNT
<i>Lot 1</i>	Video Switchers	Php 60,000.00
<i>Lot 2</i>	Dual Vocal Wireless System (Microphone)	Php 45,000.00

WHEREAS, after the closing date on 27 September 2024 only Lot 2 was successfully awarded. However, due to the participating supplier's failure to meet the delivery period and price validity requirements, the procurement for Video Switchers (Lot 1) was declared a bidding failure, leading to the reposting of the Purchase Request as per BAC Resolution No. 045, series of 2024 which is attached herein as Annex A.

WHEREAS, the PIA-BAC reposted the invitation to bid at the PhilGEPS website, the official website of the PIA as Procuring Entity, PIA social media platforms and sent the same to various prospective suppliers on 14 October 2024;

WHEREAS, following the closing date of 17 October 2024 after an invitation extended via email to various suppliers, namely: 1) Henry's Camera Trinoma, 2) Channel International Enterprises, 3) Ethereum Office Supplies and Equipment Trading, only Pinnacle Sphere Enterprises and ULY Tech Trading submitted quotations. However, it failed to meet the required price validity appearing herein as ANNEX B and Abstract of Quotation as ANNEX C;

WHEREAS, the PIA-BAC, for the third time, published the invitation to bid on 04 November 2024 at the PhilGEPS website, the official website of the PIA as the Procuring Entity, as well as on the PIA's social media platforms, and sent the invitation to various prospective suppliers.

WHEREAS, following the closing date of 07 November 2024, after an invitation was extended via email to various suppliers, only Alpha Digizone Marketing submitted a quotation provided herein as ANNEX D along with the Abstract of Quotation as ANNEX E.

WHEREAS, after assessment of the quotations received, the TWG conducted the post qualification evaluation on 20 November 2024.

WHEREAS, after careful evaluation, validation, and verification of all the legal, technical, and financial requirements of the subject procurement, the TWG found that the submitted quotation of **Alpha Digizone Marketing for LOT 1- (Video Switcher)** conforms to the requirements of PIA and the law and its price quotation of **Sixty Thousand Pesos Only (Php 60,000.00)** inclusive of tax, is within the ABC, and most advantageous to the government, thereby rendering the same as the lowest and most responsive quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, for all and in consideration of the foregoing, **WE**, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMEND** the Award of Contract *via Small Value Procurement (53.9)* to **ALPHA DIGIZONE MARKETING FOR LOT 1** in the amount of **SIXTY THOUSAND PESOS ONLY (Php 60,000.00)** inclusive of appropriate taxes and fees for the Supply and Delivery of Lot 1-2 Units Video Switcher.

This resolution shall take effect immediately.
