- c. Thirty Percent (30%) of the total Contract Price of Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.

You are likewise required to formally enter into a Contract Agreement within ten (10) calendar days from receipt of this Notice and further to confer with the PIA -BAC Secretariat, for instructions regarding the execution of this award.

The original Notice of Award with signature on "CONFORME" shall be returned immediately after its approval and signature.

Please bear in mind that failure to provide the Performance Security shall constitute sufficient grounds for rescission of the award and forfeiture of the Bid Security.
